Recently, I was notified by all three Printing Company Supervisors in Plainfield, IL, that converting PDF Documents to Century type font or any other type word formatted document will make the document unreadable and unusable.

I sent two page (Pages 1 & 4) of Judge Jeffrey Hollingsworth's Financial Disclosure statement to the PDF company to professionally convert these to Century font documents as required by Rule 33.1. The original PDF document and the converted Century font documents are enclosed for your review, These documents prove the print supervisors' concerns and assertions. These are also included in the Appendix.

One wonders, as to what useful purpose, in furthering the cause of Justice, will be served by converting perfectly legible documents, some provided by the Federal Courts themselves in Times Roman Font and PDF format, to totally unreadable and unusable century fonts!

It does not take a rocket scientist, to realize that such practices will only further the cause of injustice and fraud, by allowing white collar crooks to walk away freely and not be held accountable for their actions.

Hence, petitioner requests that Chief Justice John Roberts, suspend rule 33.1 as it pertains to submittal of documents in the Appendix as exhibits, by the petitioner, so that clear and legible documents could be presented.


All three branches of the Government have suspended their Rules, in the past in the interest of fairness and justice. Most recently within the past month Speaker John Boehner suspended House Rules to expedite a legislative action.

Hence, the Appendix is presented in the page format with 20 lb. standard paper. If the court requires that this exhibit/ appendix alone be printed on a 65 bond paper (single sided and size 8.5" by 11 ", )the petitioner is willing to resubmit them, within 10 days of his receipt of such notification.

Failure to suspend rule 33.1 as it applies to petitioner's Appendix document, would seriously affect the credibility of this Court in the American and World opinion, since we not only live in a World economy, but also live in a World system of Justice and fairness. A copy of this letter is also included in the attached Appendix.

The petitioner is in the process of obtaining his dual citizenship with the Government of India, which will give him access to the ICJ-The International Court of Justice and the Interpol. Being an American, he hopes Justice will be served in the American Courts. What is totally unacceptable, to the Petitioner- a Veteran Commanding Officer in the USAF- is to have his life savings stolen in the USA, under color of law, by less than honorable judges, who are named, as named Respondents in this Writ Petition. 



